1. 公司名称变更

(1) 背景和沿革

- a. 自 2003 年 10 月成立以来，TMEIC 致力于发展从株式会社东芝和三菱电机株式会社承继的工业系统业务，同时拓展可再生能源领域和全球市场。在此期间，打造了独具特色的“TMEIC”品牌，提升了品牌知名度和渗透力。
- b. 在 2023 年 10 月公司成立 20 周年、面向未来发展之际，决定将公司名称从“东芝三菱电机产业系统株式会社”变更为“株式会社 TMEIC”，自 2024 年 4 月 1 日起生效，以巩固品牌名称“TMEIC”。
- c. 作为 TMEIC 的全资子公司，TMEIC 中国自 2025 年 1 月 1 日起正式更名为提迈克电机工业系统（中国）有限公司。

The company name will be changed from Toshiba Mitsubishi-Electric Industrial Systems (China) Corporation to TMEIC China Corporation.

1. Company Name Change

(1) Background and Context

- a. Since its establishment in 2003, TMEIC has been developing the industrial systems business passed down from Toshiba Corporation and Mitsubishi Electric Corporation, while expanding its presence in the renewable energy sector and global markets. Efforts have also been made to establish the distinctive "TMEIC" brand and promote its recognition and penetration.
- b. Upon commemorating its 20th anniversary in October 2023 and striving for the next phase of growth, the decision was made to change the company name from Toshiba Mitsubishi-Electric Industrial Systems Corporation to TMEIC Corporation, effective April 1, 2024, underpinning its brand name, "TMEIC."
- c. TMEIC China, being the wholly-owned subsidiary of TMEIC, will change the company name to TMEIC China Corporation.
